From St. Louis: Take I-44 West (about 25 miles from I-270) to Highway 50. Go West on Highway 50 about 5 miles. When you are entering Union you will pass a McDonalds on your Right. Stay on Highway 50 West another $2 / 10$ of a mile to Church Street on your Right. (It's the second street on the Right after Highway 47 North) Make a Right onto Church Street and go 9-10 blocks to East Park Street, Make a Right on East Park Street and go $\mathbf{2}$ blocks to arena on Right.

From Washington: Take Highway 47 South (about 12 miles from Highway 100) When you are entering Union you will come to a stoplight (Intersection of Highway 47 , Highway V and Central Avenue) Make a Right onto Central Avenue. Go 2 blocks to Church Street. Make a Left onto Church Street and go 6-7 blocks to East Park Street, Make a Left onto East Park Street and go $\mathbf{2}$ blocks to arena on Right.
